- i) Continue to raise the progress and attainment of Pupil Premium children particularly in English and Maths so there is no gap
- ii) Continue to support the attendance, punctuality and well-being of children
- iii) Providing social and emotional support/interventions to improve attendance, behaviour and learning
- iv) Develop children's reading abilities, progress and achievement
- v) Raise the profile of reading across the school
- vi) Provision to enable access to wider curriculum e.g. after school clubs, music lessons, breakfast club
- vii) Provision to enable children to access wider learning experiences e.g. visits
- viii) Provision of breakfast to ensure children have adequate nourishment before school

• Our focus on attendance and promotion of the importance of learning means that the attendance of pupils is good. In the 2019-2020 Autumn Term, the overall attendance was 96.8%. After this point, attendance was affected by Covid related absence and therefore is not representative.

Due to the Covid-19 national lockdown, data is based on our in house December data point. Due to targeted interventions over the year, levels were likely to rise and be in line with previous years attainment.

• Children not reaching ARE at the time, were involved in targeted intervention groups and we predicted to reach attainment goals in line with previous years (75-80% ARE and 20-25% GD).

Covid-19 Lockdown Measures:

Due to the national lockdown, we provided families with a variety of support over the Spring and Summer Terms, including but limited to:

- Provision of food hampers in line with the national scheme as well as additional food support, working alongside local charities and businesses.
- Provision of additional school supplies and resources, such as stationary, paper, reading books and games.
- Delivery of supplies to households when parents were unable to travel.
- Regular contact via class teachers and the school learning mentor and doorstep welfare checks where needed.
- Offer of spaces in school provision for our needlest families.

Actions for 2020-21

- Gain and understanding of the learning loss due to the missed school time
- Put in place regular targeted interventions for all children, but particularly disadvantaged children to ensure that this is caught up quickly.
- Leaders will work closely with teachers to monitor progress and next steps.
- A programme of wellbeing will be introduced to ensure that children are ready to learn and comfortable back in the school environment.
